In this is love, not that we loved God, but that He loved us and sent His Son to be the propitiation for our sins. 1 John 4:10

Dear Friends,

Unconditional love! None of us deserve God's unconditional love, but that is exactly what He offers each of us. Paul put it this way: *For while we were still helpless, at the right time Christ died for the ungodly. For one will hardly die for a righteous man; though perhaps for the good man someone would dare even to die. But God demonstrates His own love toward us, in that while we were yet sinners, Christ died for us.* (Romans 5:6-8). Those of us who have received His unconditional love can do nothing less than share His love with others.

We are very grateful for your partnership with us in sharing God's unconditional love with those who are in desperate need. Please pray with us as we continue to minister throughout the coming year in a variety of ways:

- 1) **Missionary Station Radio HRGS**— operating BBI's missionary station in the Bay Islands of Honduras since July, 1990;
- 2) **Radio Program Broadcasting Overseas** — providing new and untaught believers simplified, systematic Bible teaching as a foundation for their Christian faith through missionary radio broadcasts; BBI's Spanish language program is on more than 100 stations;
- 3) **Church Planting and Cable TV Broadcasting** — evangelizing, discipling, church planting, and a weekly cable TV broadcast in the Malayalam language in India in partnership with Missions India;
- 4) **Program Production** — producing radio programs in its Florida studios for broadcast in the USA and abroad;
- 5) **Biblical Literature** — publishing and distributing of BBI books in several languages, study guides, and tracts;
- 6) **Evangelism and Training Teams** — conducting evangelistic and teaching campaigns overseas known as STAR Teams (Sowing, Teaching And Reaping); North Americans work with groups of churches in various locations to evangelize and disciple in their local areas;
- 7) **Webcasting** — BBI program material is webcast in Spanish and in Farsi, the language of Iran.

Unconditional love! God's love for us is only part of the picture. The apostle John said, *Beloved, if God so loved us, we also ought to love one another* (1 John 4:11). The difficult times in which we are living should make us mindful of others as God is mindful of us. Let us be especially careful to care for others as God enables us: *Let each of you look out not only for his own interests, but also for the interests of others* (Phil 2:4).



Christmas for your Missionaries

**Two ways you can send a gift
to your missionaries for Christmas.**

- 1. A Non-tax Deductible Christmas gift** – Your Christmas gift will be passed on directly and in full to the designated recipient, but your receipt cannot be tax-deductible.
- 2. A Tax Deductible gift toward a Christmas Bonus** – If you want a tax-deductible receipt, your gift will be used to pay a Christmas bonus to the designated missionary, but payroll taxes must be withheld when paid to the missionary.

Examples: "New regular support for (missionary or project)," "One-time contribution for (missionary or project)," etc. **Please note:** In the unlikely event that designated donations exceed the amount needed for a particular project, the balance will be used toward another missionary ministry of BBI.
